MINUTES OF THE PARISH COUNCIL MEETING
HELD 3 JULY 2008

Apologies for absence were received from Cllr Mr B Curran, Cllr Mr G Oxley and Cllr Mr A Hooper and the reasons for absence were approved by the Committee.

Prior to the start of official business Cllr Mrs D Fearnley welcomed two visitors to the meeting.

- Mr Steve Lloyd and Mr Tom Bishell who are both Branch Officers of the Public and Services Union regarding the proposed closure of Chapeltown Job Centre. They reported that unless there was opposition locally to this closure it would take place following consultation. The Government have invested money in call centres and were closing Job Centres up and down the country, but people prefer to deal face to face rather than using call centres. If the Chapeltown Branch closes the nearest Centre would be at either Hillsborough, Rotherham or Barnsley. This would increase costs to people already on reduced incomes by £3.00 - £5.00 each trip. Mr Lloyd reported that not only was the building used as a Job Centre but also people could access other services such as information on Disability Benefit, Sickness Benefit, New Deal for Lone Parents, computerised Job Point, Sheffield Homes and First Point. Mr Lloyd reported that they had a petition with 2,000 signatures on it and this has been handed in to Sheffield City Council and also an online petition on the Parliamentary website.
- Cllr Mr S Bower said all Parish Councillors were in support of keeping open the Job Centre and it was agreed unanimously to send letters of support to this effect to the Job Centre Plus District Manager and the Minister for Work and Pensions.
