A further application 10/02658/FUL was made to the City Council but the Parish Council were not informed of this application, which was subsequently refused with enforcement action in March 2011. The Planning Committee support the residents objections on the following grounds:-</p> <ul style="list-style-type: none"> <li>Ø Delivery vehicles park on single yellow lines causing a possible traffic hazard.</li> <li>Ø Increased traffic and litter on site, parked vehicles often encroach the neighbours’ driveways; licensed taxis are now also using the parking area whilst awaiting their next booking.</li> <li>Ø Noise pollution from the proposed air handling equipment to the rear elevation, which is directly in front of neighbouring properties.</li> <li>Ø Cooking smells from the property, which also make it impossible for the neighbours to enjoy using their gardens.</li> </ul>
