MINUTES OF THE ENVIRONMENTAL PLANNING & EMPLOYMENT COMMITTEE MEETING HELD 6TH DECEMBER 2012

Present were Councillors A Hooper (Chairman), Dr J Bowden, B Granger, Mrs K Granger, Mrs D Fearnley, J Jones, H House, J Housley, A Bainbridge

In attendance: Mrs G Kress, Admin. Officer

Teachers and members of the School Council from both High Green Primary and St. Mary Catholic School and approximately 60 members of the public were also in attendance for planning application 12/03543. Site of old Cart and Horses Inn, 2 Wortley Road, High Green, Sheffield.

Apologies for absence were received from Cllr D Pepper and the reason for absence was approved by the Committee

13/73. Declarations of personal and/or pecuniary interest

There were none received.

13/74. Exclusion of the press and public

There were none identified.

13/75. Planning Proposals for consideration

12/03543/FUL. Site of Old Cart and Horses Inn, 2 Wortley Road, High Green, Sheffield S35 4LU. Approximately 60 members of the public attended the meeting to voice their concerns about the proposed planning application which would entail the demolition of the existing public house and erection of a convenience store (Use Class A1) and hot food takeaway (Use Class A5).

Members of the public were invited by the Chair of the meeting to give their reasons for objection to the proposed development and the children from the school councils were also given the opportunity to speak when they informed the Committee of their findings of a survey taken at the school of pupils, parents, teachers and grandparents, on whether they would like this development to take place.

The Committee recognised the strength of feeling of local residents and businesses against the proposed development and agreed to support their objections on the following grounds:-

The main area of concern is congestion of traffic on an already very busy road. The road is the main arterial road through the village and the impact that the delivery vehicles and increased traffic would have on not only Wortley Road but also Jeffcock Road and Mortomley Lane. A survey carried out on behalf of Punch Partnerships which forms part of the planning application was done on a Friday afternoon between 15.30 and 18.00 hours and on Saturday between 10.00 and 12.00 hours. The Committee would like to request that an independent survey be performed for a longer period of time covering the school opening and closing times as this would give a very different picture of the traffic flow.

- A resident who attended the meeting and is also a planning consultant stated that % be proposed development is in conflict with the Unitary Development Plan which states that the road from Thompson Hill down Wortley Road is deemed to be an area of special character. It is also an area which is designated for any future development as housing, not commercial development. The public house which it is proposed will be demolished, is one of the oldest buildings in High Green dating back to approximately 1643. Due to the historical value of this building it was felt important that this be preserved within the village.
- Safety aspect. there are two schools in close proximity to the proposed development and any heavy goods vehicles and also additional traffic calling in at the proposed supermarket would have a serious effect on pedestrians. There have already been serious injuries to pedestrians on the road. Any delivery vehicles would have to reverse into the car park; the area in question is a very narrow part of the road and it is uncertain whether it would be possible for these types of vehicles to negotiate this action.

The Headteacher from one of the schools stated that the children also regularly walk down Wortley Road when they are going out on educational visits. The pathway is narrow and in the past vehicles have mounted the kerb when another vehicle is coming in the opposite direction. The schools also experience difficulties when they have coach trips planned as the road is not wide enough to accommodate coaches easily and does cause serious congestion at busy times. The Committee would therefore like to request that a site visit be made to assess the impact of this on pedestrians, car users, buses and emergency vehicles.

- Weight limit on the road. residents enquired whether there was any weight restriction such as the one through Chapeltown up to Wortley Road which is a 7 and a half tonne weight restriction. Some of the vehicles which deliver to these supermarkets are 26 tonne rigid vehicles. The Committee requested that clarification be sought as to the weight limit of this road.
- Noise issues. the Licensing application that has been applied for states that the
 opening times from Sunday to Saturday are to be from 0.00 to 24.00 hours and that
 the sale of alcohol is Sunday to Saturday 6.00 to 24.00 hours. The Committee are
 concerned about the large delivery vehicles visiting the site as it would appear to be
 24 hour opening and this would have a serious noise impact on neighbouring
 properties.
- Impact on current businesses in the village. the Parish Council are concerned about the possible detrimental effect on the local businesses, with the view that job losses will possibly outweigh job gains.
- The size of the consultation by Sheffield City Council was very limited with only immediate neighbouring properties in the vicinity being notified with a very limited timescale for notification. The Parish Council were only notified on the 26 November with comments being sought by the 12 December.

The Committee therefore requested that the Clerk write to the Head of Planning at Sheffield City Council asking that:-

- A site visit be made to assess the impact of the proposed development within the whole village.
- An independent traffic survey be undertaken at the additional hours requested as the traffic survey was only carried out over a short period of time by the applicant.
- That the decision is made by the Board rather than a delegated officer
- That clarification is sought regarding the weight limit on the road and the size of vehicles proposed to deliver in the area.
- The preservation of one of the oldest buildings in High Green and the possible future use of the adjacent site for residential property rather than commercial property.
- A public consultation should take place with representatives from Sainsbury
 s, and Punch Taverns and members of the public being invited to put forward their views.

At this point of the meeting members of the public vacated the premises and due to the school councils being present it was decided that the Planning Committee would consider the rest of the plans after the full Council meeting.

The Planning Committee recommenced business at 9.00pm at which point Cllr Jones had left the meeting. A further eight plans were considered to which no objections had been received by the Committee . there were no objections on the City Council website to any of them. Therefore a letter is to be sent to the Head of Planning stating that there are no objections to any of the additional plans.

No apologies were received, all the Committee were present for the meeting.

13/84. Declarations of Interest

There were none received.

13/85. Exclusion of the Press and Public

There were none identified.

13/86. To confirm, for the period ending 30th November 2012 (a) receipts schedule (b) payments schedule (c) account/bank reconciliation and (d) budget and management accounts

RECOMMENDED: That the receipts schedule, payment schedule, account/bank reconciliation and budget and management accounts for the period ending 30 November 2012, as now presented by the Clerk & Financial Officer be confirmed.

13/87. Applications for Financial Assistance

13/87(1) Westwood Training Ltd.

One Volunteer Education Worker attended the meeting to inform members why the group required financial assistance. The Group would like to run a Family Learning Day during the February half term. The only funding that they receive from elsewhere is from the Ecclesfield Welfare Charities. The Group cater for the 4-11 age group and parents attend with their children, there are approximately 25 children attending at each session and they hope to run two sessions. They require funding to assist with the cost of materials, room hire and publicity for the event.

RECOMMENDED: that a grant of £250 be given to the group for running two sessions, with the proviso that if they are willing to run a third session then a grant of up to £400 be provided.

13/87(2) Chapeltown & District Amateur Operatic Society

Two members of the society attended the meeting to inform members of their need for financial assistance towards the cost of staging two shows in the summer of 2013. The society has been running since 1924 and their members range in age from 8-83. Each show costs £15,000 to stage and they require assistance to purchase new lighting, hiring of costumes, room hire and rehearsal accompanist.

RECOMMENDED: That a grant of £900 be given to the group to purchase the lights.

13/87(3) Chapeltown Baths CB Ltd.

The Manager of Chapeltown Baths attended the meeting to inform the Committee of the need for a grant towards the purchase of emergency lighting for the basement gym which requires upgrading to ensure compliance with safety standards. One quote has already been received from a company who have previously done work at the Baths. The Committee requested that two further quotes be sought in order that the best price may be obtained.

RECOMMENDED: That a grant of up to £1500 be given towards the upgrading of the lighting system.

13/88. To approve the content and style of the Finance leaflet for approval at January 2013 Council

The Clerk informed members of an e-mail received from Sheffield City Council with regard to their plans for issuing the City Council finance details to residents. At present the City Council are still in discussion about the level at which the council rate will be fixed at. Discussion took place regarding the best way to inform residents of the Parish Council precept and it was suggested that the information could be placed on the Parish Councils website. The Clerk was asked to contact Look Local and get a quote for placing details of the finance leaflet in an edition of the newspaper. The Clerk stated that this item may have to be added as an item for approval at full Council in January 2013 rather than the Finance Committee in January 2013.

13/89. To consider repayment of the loan to the Public Works Loan Board

The Clerk informed the Committee of the amount still remaining on the PWLB Loan for the building of the Parish Council offices. He explained that there would be no financial benefit in paying off the loan as no discount would be received back for early repayment of the loan. However the funds received from the sale of the David Chadwick Centre is capital funding which can only be spent in certain ways. Paying off the loan is an option that should be considered as this would then free up revenue funding of approximately £2,300 per year that had been allocated for this purpose.

RECOMMENDED: That the proceeds from the sale of the David Chadwick Centre be used to pay off the PWLB loan.

13/90. Correspondence

Item 5 . Removal of bench on Worrall Road . Following an e-mail received from Sheffield Homes regarding the cost of the removal of the bench, the Clerk suggested that he be given delegated authority to bring this matter to a conclusion before Christmas. This was approved by the Committee and the Clerk was requested to act on this matter as soon as possible.

MINUTES OF THE ENVIRONMENTAL PLANNING & EMPLOYMENT COMMITTEE MEETING HELD 18TH DECEMBER 2012

Present were Councillors A Hooper (Chairman), Dr J Bowden, B Granger, Mrs K Granger, Mrs D Fearnley, H House, J Housley, A Bainbridge and Ms V Bowden as substitute for Cllr Jones.

In attendance: D Morton, Clerk and Mrs G Kress, Admin. Officer

Apologies for absence were received from Cllrs D Pepper and J Jones and the reasons for absence were approved by the Committee

13/78. Declarations of personal and/or pecuniary interest

There were none received.

13/79. Exclusion of the press and public

There were none identified.

13/80. Planning Proposals for consideration

Two planning applications were considered for telecommunications monopoles . one on Thompson Hill at the junction with Foster Way and the other on Greengate Lane at the junction with Worrall Road. Over 200 letters had been delivered to neighbouring properties but no objections or comments had been received by the Parish Council. There were no comments on the City Council website either; therefore the Committee could see no grounds for objection.

Letter to HOP SCC

13/81. Licence Applications

No licence applications had been received for consideration.

13/82. To receive an update on the EPIP project

The Clerk updated the Committee on the progress made to date with regard to the EPIP funding application for the interpretation boards and new walks leaflets. Three companies had been invited to tender but only two tenders had been received. The chosen company is Oakleaf Graphics who have now commenced work on this project.

Four out of the five locations have been identified for the interpretation boards with one location still to be agreed. The suggested sites to date are:-

- Two in Chapeltown . one outside Chapeltown Library and the other outside Newton Hall.
- Chambers Road . to include the history of the Thorncliffe Estate
- Westwood Country Park . at the Dowland entrance to the park
- Suggested sites for the other board are . the Burncross area which will include Barnes Hall, Horbury, Chapel Road, Sweet Pea Row

As Grenoside and Ecclesfield already have the interpretation boards in the vicinity it was not felt necessary to place any more boards in those areas of the Parish.

Following discussion with Chris Prescott he advised that the number of walks leaflets be reduced from 10 to 8. It was agreed to increase the size of the leaflets from A4 to A3 in order to allow more detailed information to be included. There is still one walk location to be agreed.

The Clerk suggested that Chris Prescott be invited to attend the January Council meeting to update members on work carried out to date.

The Clerk informed members of several ideas for consideration in the New Year . these being:-

- The opportunity for possible EPIP funding towards archiving extremely valuable historical documents within the Parish. Professor Mel Jones and his wife have many documents regarding the history within the Parish. the documentation could be digitised and available for all to see on the Parish Council website. The Committee felt that this would be a worthwhile project to explore further and requested that this be placed on the mid-month planning agenda in January for further discussion.
- The Clerk also acknowledged that there are a lot of local groups working in the Chapeltown area and he suggested that the Committee could invite these groups to come to the Parish Council to speak about the work that they carry out within the Parish.
- The Clerk had recently attended a Neighbourhood Planning Workshop at the City Council and suggested to members that this should be taken on board and work alongside the City Council.

13/83. Correspondence

To consider items requiring action or a response.

- **Items 1-12** Members noted the large number of objections received to the Planning application at the site of the Old Cart and Horses Public House. These have been forwarded to the City Council as well for information.
- **Item 16**. Members were reminded of the Annual Carol Concert in Chapeltown Park on the 19 December 2012.
- **Item 19**. Bench on Worrall Road. The Clerk informed the Committee that he had been given delegated power by the Finance Committee to act on this matter. The bench will be removed on the 20 December from Worrall Road to Mortomley Park where Friends of High Green in Bloom are siting it in the rose garden.
- Item 21 . Hesley Wood Planning application . It had come to the attention of Cllr Housley that the City Council Planning Board were planning to meet on the 2 January to consider this application. The Committee requested that the Clerk write to the City Council requesting that this be considered at a more appropriate time as many people would still be on holiday following Christmas and New Year Bank Holidays, in order that members of the Parish Council Planning Committee and also local residents and groups can attend the meeting to put forward their views on this application.

Item 23. Bus Services. Comments had been received from a member of the High Green Action Team regarding the number of buses on Wortley Road and also the fare increases. The Committee requested that the e-mail be sent to the South Yorkshire Passenger Transport Executive and also the Highways Cabinet at Sheffield City Council.

Item 24 . Pedestrian safety on Arundel Road . An e-mail had been received from a resident regarding the number of vehicles mounting the kerb whilst driving down this road from the Asda. This e-mail has already been sent to the Highways Department at Sheffield City Council but the Committee requested that it be sent to the Northern Community Assembly with suggestions regarding pedestrian safety.

Cllr Bainbridge requested that the Planning Committee be informed of planning decisions made by the City Council Planning Department. This is now an easier process as these are received electronically. They will now be forwarded on to the Planning Committee as and when they are received.
