The fencing is also not as specified on the application as it is not acoustic fencing and the planting provided does not provide sufficient privacy and noise reduction to residents in neighbouring properties.

The Committee are in full support of the residentsqobjections due to the continual disregard by the applicant of planning regulations and the Committee asked that the Clerk write to the Head of Planning at Sheffield City Council requesting that the decision be made by the Committee rather than a delegated officer.

The Committee also requested that a copy of the original letter sent from Ecclesfield Parish Council with regard to the earlier planning application be sent in, which requests that no outside seating be provided, in order to protect the privacy and prevent noise issues which may affect the residents of neighbouring properties.
