MINUTES OF THE PARISH COUNCIL MEETING HELD 8 JANUARY 2015

Apologies for absence were received from Cllr Jones and the reason for absence was approved by the Council.

Three visitors were present at the meeting.

The Chairman presented a Chairman's award to Mrs Doris Denton who is the Chair of Friends of Chapeltown and High Green Parks in recognition of all the work carried out over the past few years. Mrs Denton stated that thanks to the kind donations from Ecclesfield Parish Council which enabled match funding from Veolia, the skate park would now be able to go ahead. An outdoor gym will also be erected and a flower meadow is being created in the Oxley Orchard this year.

Mr M Appleby from Chapelgreen Advice Centre introduced himself to Council and said stated that he hopes to become more involved with the Parish Council as he is standing as a member in the elections in May 2015.

Mrs A Gethin had attended the meeting to request an update on Chapeltown toilets. The Chairman brought this item forward in order that members of the public could be present to hear the report from the Finance Committee. Two quotes had been sought for the maintenance work but only one quote had been received. It had been recommended by the Finance Committee that this firm be appointed to run the toilets on behalf of the Parish Council. This will be at a cost of £6,230.00 + VAT per year. The Council agreed that the Clerk invite the firm to meet with him to review the condition of the toilets and if they are in a satisfactory condition to open them as soon as possible.

The Clerk has instructed Shield Estates to commence marketing of the Chapeltown Baths site which should take place over the next few weeks.

A letter had been sent to the Licensing Department regarding the Licence application for Pizza Hut which had been received for consideration at the last planning meeting. The Licensing Department had requested further evidence as to why the Parish Council were objecting to the application. A letter had also been sent to South Yorkshire Police who had responded to say that they shared our concerns with regard to the extended opening hours. The Committee requested that a further response be sent to the Licensing Department on the following grounds:-

- Prevention of Crime and Disorder the Committee felt that there would be an increase in crime and disorder from late night drinking as most of the public houses in the vicinity close at 11.00pm and the sale of alcohol beyond this time would give people a reason to stay in the vicinity.
- Prevention of Public Nuisance the Committee felt that there would be the
 potential of noise nuisance to local residents which would affect their quality of
 life should the hours be extended beyond the normal closure time of similar
 establishments.
- Promotion of Public Safety the Committee felt that it would be inappropriate
 to agree to the extended opening hours as it could encourage binge drinking
 and is not appropriate in a residential area, the opening hours are also not in
 line with other similar establishments in the area. It would also be difficult to
 control the sale of alcohol to minors.

Cllr Bainbridge stated that he had spoken to Angela Smith, MP who felt it was inappropriate in a residential area and that she would be writing to the Licensing Department.

15/99. To consider the Sheffield WildlifeTrust draft management plan for Greno Woods – comments to be submitted by 25 January 2015

Members had had the opportunity to read the draft Management Plan which is a six year plan and the Clerk was requested to respond to say that Ecclesfield Parish Council support the plan. The main issue of concern is regarding the different users of the woods and wish to ensure that everyone has freedom to use the woods.

The Parish Council have a particular interest in the history of the site as the Parish Council have recently employed an Archive Project Co-ordinator following a successful bid for Heritage Lottery Funding. The Clerk was requested to pass on the contact details of the Co-ordinator who could perhaps offer some support to the proposed oral history part of the plan.

Clerk to respond to Sheffield Wildlife Trust

15/100. To consider correspondence received from a resident regarding the Green Belt areas within the Ecclesfield Parish

A resident of Ecclesfield had written in to the Parish Council with a request for support from the Parish Council in protecting the Green Belt areas within the Parish. He was in attendance at the meeting and said he had been prompted to respond to a letter that he had received from Sheffield City Council with regard to the "Sheffield Local Plan – Call for sites and consultation update, including sites which are in the Green Belt which will be assessed as part of the Green Belt review".

Members considered the correspondence received and agreed to support the resident in his request to protect the Green Belt within the Parish and write to Sheffield City Council to see if any Green Belt sites had been identified as a result of the letter sent out in July 2014. The Committee also requested that the Clerk write to the City Council to ask that the Parish Council be informed of the outcome of consultation carried out in 2014. It was agreed that the Clerk would contact the resident to discuss the matter further along with the Chair of Planning and that a letter be sent to the City Council regarding this matter.

Cllr Bainbridge informed members that he had been contacted by a resident with a petition for a grit bin to be reinstated on one of the estates in Chapeltown. The resident has since been invited to attend a meeting at the City Council when such requests are being considered.
