MINUTES OF THE PARISH COUNCIL MEETING  
HELD 3 NOVEMBER 2016

Present: Cllrs Mrs K Granger (Chairman), M Appleby, J Housley, Ms S Constance, G Oxley, D Pepper, Mrs D Fearnley, Mrs Z Sykes, A Hooper, E Hanson, G Weatherall, J Brownrigg and Mrs A Brownrigg

In Attendance: D Morton, Clerk & Mrs G Kress, Admin. Officer

Apologies for absence were received from Cllrs Mrs A Gethin and A Henstock and the reasons for absence were approved by the Council.

Sheffield City Councillor A Bainbridge and two members of the public were present at the meeting. The Chairman invited the members of the public to speak or if they had written requests to present them to the members.

The first resident handed out his proposal for the parks in High Green and it was agreed to send them to the Councillors who were not present at the meeting.

The second resident read out his comments with regard to the recent opening of the Angram Bank Skate Park. He stated that Cllr Mrs D Fearnley had been present at the opening but that there had been no other Councillors representing Labour or Lib Dem groups and that he had been disappointed. Members noted his comments.

17/87. To a) receive any amended declarations of interest from members and b) To receive any declarations of personal and/or disclosable pecuniary interests from members of the council on items to be discussed at this meeting

There were none received.

There were no items identified which required the exclusion of the press and public.

That the minutes be approved as a correct record of the meeting, subject to the following minor amendments.

Cllr J Brownrigg stated that a member of staff had been missed out as being present at the last Council meeting and it was agreed that Miss L Tickle, Administration Assistant be added as being in attendance.

Minute 17/77 – Cllr Housley stated that he had enquired whether a letter had been sent to Sheffield City Council about the Chapeltown Park signs instead of Cllr Mrs A Gethin as stated in the minutes.

Cllr Housley stated that the signs are still not in place. City Councillor A Bainbridge informed Council that he knows that one of the signs is currently in the process of being made and that he will check the progress of the other sign. Cllr Housley stated

that he had been informed that the cost of the sign quoted is £3,300 and is subject to the design being approved by Amey. Cllr Hooper stated that no written reply had been received from the City Council and the Clerk was requested to ask for a written reply rather than word of mouth.

**Letter to be sent to SCC**

Cllr Pepper enquired whether a response had been received back from Inspector Burgess at South Yorkshire Police with regard to the anti-social behaviour rates in various areas of the Parish, which Police Sergeant Lee Kayne had been unable to answer. It was agreed that a letter be sent to South Yorkshire Police to enquire about this.

Cllr Mrs A Brownrigg stated that she had submitted her apologies for the meeting and requested that these be included in the minutes.

The Clerk also reported to full Council that as per minute 17/52 a meeting is due to be held regarding the refurbishment of the Alan Greaves Community Room. This is to be an agenda item for the Finance Committee to be held on the 24 November to agree a draft budget, then it will go to the next available Planning meeting for consideration and then a consultation meeting will take place with the current users of the room.

The Clerk also informed Council that an officer at Sheffield City Council – John Corris with whom the Parish Council had a working relationship for the past year had passed away at the weekend. He said it was a sad loss to Sheffield City Council, the Parish Council and Community Groups who knew him. The Clerk was requested to send a letter of condolence to his family.

17/94. To receive a verbal report from the Environmental Planning Committee Meeting held 3 November 2016

Cllr E Hanson reported that eight planning applications had been received for consideration. Responses to the applications would be sent to the Head of Planning at Sheffield City Council.

17/95. To receive a report from the Chair of the Archiving Project (Mr A Bainbridge)

City Councillor A Bainbridge reported that a lot of things had been happening behind the scenes. Volunteer sessions are taking place each week with several volunteers now recruited. The second batch of documentation from the EPPiC Theatre is being digitised and is progressing well.

On the 13 October a meeting of the Steering Group was held and he had asked for ideas from members of the group when the HLF Project comes to an end. No ideas had been forthcoming, Mr Bainbridge stated that he would be happy to continue chairing the meetings. On the 15 December 2016, the final group meeting will be held then he would meet with Christine Handley and the Clerk in January before the project finishes.

The reminiscing sessions at Ecclesfield Library are continuing and they have now received from Sheffield City Council history books regarding the Gatty family. These are local history reference books which can be viewed in the library.

Christine is adding new content onto the website along with updating the blog on the Parish Council website and the Facebook page. She has also approached the HLF about producing a DVD. Cllr D Pepper enquired about the portable equipment that could be taken to local places such as the Grenoside Gala in June next year. Mr Bainbridge stated that Christine had asked the HLF about this.

17/96 To consider a request from the Chapeltown Forum to use the Chapeltown Baths Car Park for a Community event at Christmas

The Clerk reported that events had overtaken this request due to the impending demolition of the baths and this item was therefore withdrawn. The Clerk reported that the site had recently been vandalised and he had been notified by the Purchasers of the baths that boarding up of the premises will be done this week followed by soft stripping of the baths and demolition thereafter.

Apologies for absence were received from Mrs A Gethin and G Weatherall and the reasons for absence were approved by the Committee.

17/54. To receive any declarations of personal and/or disclosable pecuniary interests from members on items to be discussed at this meeting

Cllr A Hooper declared an interest in planning application 16/03915/FUL – Costcutter, Bevan Way as he has a personal interest in a neighbouring property.

17/55. To identify items for discussion which may require the exclusion of the press and public  
There were no items identified which required the exclusion of the press and public.

In respect of planning application no 16/03410 the Planning Committee acknowledged that the Parish Council has engaged Shield Estates to undertake professional services on its behalf in respect of an unrelated matter. In the case of this planning application, the members stated that they will consider its merits or otherwise with an open mind, in like manner to all other planning applications received.

In respect of planning application no. 16/03836 the Planning Committee acknowledged that they are the current owners of the Chapelton Baths site and the application is in the name of the Purchaser of the site.

17/56. Planning Proposals - to consider applications received

Eight planning applications had been received for consideration. The only objections received were for planning application 16/03410 – 62, 64 and 66 High Street, Ecclesfield – This application had been considered by the Planning Committee at their meeting on the 20 October and due to objections and issues, had agreed to consider it further at this meeting. Following consideration and comments made by various Councillors it was voted upon and agreed by the majority that the Parish Council have no objection to the planning application but requested that the decision be made by the Board rather than a delegated officer and that the comments of residents of neighbouring properties be taken into account in the decision-making process.

Cllr Hooper said that he was concerned that Ecclesfield may lose its identity as a village shopping centre and was concerned to see the number of empty retail units. Cllr Hooper stated that Sheffield City Council should do an urgent review of the shopping centre in Ecclesfield as this proposed development will create a further loss of local businesses.

A recorded vote was requested on this item with the following result.
