- It purchases the various time capsules and contacts the schools, parks, and the local volunteer groups, as outlined above 2021/70 (3) (F&P).

It is good practice for a Council to review its Standing Orders at least on an annual basis. The Council was independently reviewed as part of Moses/Presland Ecclesfield Intervention Report 2021. This in its final report stated, '*These appear to be up to date and based upon the NALC model template as at May 2020.However, the Council may wish to address the following: "4 Committees and sub committees" – Ecclesfield's order just refers to Committees, this will need to be changed if ever the council put sub committees into place. (Likewise, under 7.a sub committees are mentioned - the orders just need some consistency). 4.d (v) – the number of days before a meeting is not included 13 (e) – if the chair makes a decision could this politically be a problem? 18 Financial Controls – f. and g. need to be updated in line with NALC LTN 87 Procurement, Feb 2021'. The revised document is attached at item 132a. This incorporates the minor amendments suggested following the Moses/Pressland intervention report. The opportunity has also been taken to incorporate the Remote Meetings – Standing Order Addendum approved by the Council at it May 2020 meeting (minute 18 2020/21).*

NB – It should be noted that the draft Standing Orders is a very large document.
