- It is recommended to Council that BT be appointed to provide its Telephone and Telecommunications service for 2022/2023 on the basis of their quote dated 29 November 2021 – 2021/93 (F&P).
- It is recommended to Council that:
 1. Thomas Fattorni Ltd be appointed to repair and enhance the Chairman's Chain of Office and pendant up to a value of £3,250, plus VAT.

2. A display case be purchased from Displays UK up to a value of £250, plus VAT. 3. A specific earmarked reserve be provided in the budget for repairs and improvements to the Chairman's Chain and that £250 a year be allocated to it for this purpose - 2021/95 (F&P).
