I thought I would just outline in this email a bit about the Friends of Grenoside Park as this is our first funding application.

The group is very new (we only set up and signed our constitution in May 2022) and is made up of local parents with the aim of securing funds for new playground equipment in the park. We are of the view that Grenoside Park is in need of updating as some of the equipment in it is over 30 years old.

Our first goal is to consult with other parents in Grenoside to ask them what they would like to see in the playground. Our plan is do this by asking them to complete an online survey which we will have on our website (<a href="www.friendsofgrenosidepark.co.uk">www.friendsofgrenosidepark.co.uk</a>) the website is still in the design phase but you can see how it will look below -





The URL we have chosen is free for the first year but we would like to purchase a SSL Certificate as we are asking people to provide their email address when they complete the survey and the certificate will help to keep their data secure. The cost of the certificate is included in the application.

As stated in the application as we are brand new we do not have any insurance yet and have included the cost of the insurance premium in the application. This is our first application for funding and so we have not

attached any bank statements as our account is currently empty however if you would like us to forward copies of our statements to show this please do let me know.

Finally we also attach a copy of our constitution and document showing that two people are required to authorise payments from our account (please see 3.1 of attached mandate)
