Proposed by Councillor David Ogle and seconded by Councillor Victoria Bowden and <b>RESOLVED:</b> That it is recommended to Council that the High Green Athletic Club be granted an award of £2,000 for pitch hire at SGP Thorncliffe for one season and the remainder towards the cost of a sports camera from the Ward Based Grant (Burncross, Chapeltown, High Green and Thorncliffe wards). <i>(5 in favour)</i></p> <p>2. Proposed by Councillor David Ogle and seconded by Councillor Carol Levery and <b>RESOLVED:</b> It is recommended to Council that High Green Development Trust be granted an award of £1,255 towards equipment to build a water storage station at the new allotment site at High Green from the Ward Based Grant (High Green and Thorncliffe wards). <i>(5 in favour)</i></p> <p>3. <p><b><u>2022/14</u></b> <b><u>(F&amp;P)</u></b></p>	<p><b><u>Item 14: Alan Greaves Fund Proposal</u></b></p> <p>Councillor David Ogle led this item.</p> <p>He reminded Councillors that the initial proposal aimed at reducing crime and anti-social behaviour was considered at the 21 April 2022 meeting of the Finance and Premises Committee (Item 2021/134 (F&amp;P)). At this meeting, it was agreed that all Councillors be asked to comment on the initial proposal, many of which did. He thanked everyone who had commented. The proposal was then the subject of a detailed debate.</p>

	<p>Proposed by Councillor David Ogle and seconded by Councillor Carol Levery and <b>RESOLVED:</b> It is recommended to Council that:</p> <ul style="list-style-type: none"> <li>a) It approves and supports, in principle, the proposal developed by Councillor David Ogle aimed at reducing crime and anti-social behaviour.</li> <li>b) The 'Alan Greaves' budget heading of £10,000 be earmarked in support of this project.</li> <li>c) It authorises Councillor David Ogle to approach on behalf of the Council non-grant giving bodies and other organisations to gather more information and their potential support in furtherance of the proposal.</li> <li>d) It authorises Councillor David Ogle to identify and prepare in conjunction with the Clerk funding bids in support of the proposal.</li> <li>e) A Working Party comprising Councillors and non-Councillors be established to take the proposal forward.</li> </ul> <p style="text-align: right;"><i>(5 in favour)</i></p>

He explained that the refurbishment works were coming to an end, and the Hall would be re-opening soon.</p> <p>He referred to an issue with the floor covering. It had been suggested that this should be laminate or similar. The general view was that this was a good idea. It did not, however, form part of the specification, which had listed carpets. If Councillors favoured laminate or similar flooring there would be an additional cost. The general view was that laminate flooring was preferred if cost effective. The Clerk agreed to obtain quotes for this work.</p>
