Item 16: To receive the final report following the Jeffcock Road Survey

This item was brought forward to item 13 as members of the public were in attendance to hear the outcomes of the survey.

The Clerk read out the findings of the report to the Committee and members of the public who were in attendance. It was a joint survey in conjunction with Sheffield City Council. The survey was distributed to all houses on Jeffcock Road and 30% responded to the survey. The findings of the survey were sent to Sheffield City Council and the Sheffield City Council's North Sheffield Local Area Committee.

The main findings from the homeowners on Jeffcock Road were:

- Lack of parking.
- Inconsiderate parking.
- Speeding of cars.

Members of the public informed the Committee of the problems that they have with the traffic and parked cars on Jeffcock Road of which are pointed out below.

- Speeding through Jeffcock Road.
- A concrete post at the end of someone's property was knocked over and the car drove away.
- Pulling onto drives to reverse.
- Parking on peoples drives and pavements.

Suggestions of the below were discussed as possible measures to be put in place.

- Traffic calming measures.
- Speed bumps.
- Making Jeffcock Road a one-way street.
- Reducing speed by making Jeffcock Road a 20mph zone.
- Double yellow lines.

	<p>Parish Councillor Alan Hooper had met earlier in the day with a Sheffield City Councillor Highways Officer on Jeffcock Road and suggestions were had to maybe bring in another 20mph zone in High Green to cover Jeffcock Road. Councillor Alan Hooper made members of the public aware that the Council no longer put in speed bumps, and it wouldn't be suitable to put yellow lines as this would affect the homeowners who live on there. The Council would investigate making Jeffcock Road a one-way street, but this could cause traffic flowing through to speed up.</p> <p>Councillor Alan Hooper is in contact with the Highway's Officer and is waiting on results from them from his meeting and site visit on Thursday 8 September 2022.</p>

Since the swap shop at the end of July we have given away 535 items of school uniform and the Parish have been singing our praises on Facebook. I hope others follow your lead xx” • “Good to see a team working so well for the community, again well done.” <p>Councillor John Bowden let the Committee know that he had seen an advert in the local S35 magazine about another parish council that have the same initiative going and wondered if Ecclesfield Parish Council could have an advert put in the magazine. This will be passed onto the Community Coordinator.</p> <p>b) The Administration Officer gave an update on the Chapeltown Community Clean-up Day on behalf of the Community Coordinator. The Chapeltown Community Clean-up Day has been scheduled for Saturday 15 October 2022. We are just waiting on confirmation from Sheffield City Council for the patch of land on the corner of Scott Way / Bevan Way in Chapeltown to be used.</p> <p>c) The Administration Officer gave an update on Hedgehog Heroes on behalf of the Community Coordinator. The Community Coordinator has been asked to talk on local BBC radio about the hedgehog and nature projects. The memory cards are being continued to be swapped over in the camera for evidence of hedgehogs and interesting wildlife.</p> <p>d) The Administration Officer gave an update on the Hampers and Meals on behalf of the Community Coordinator. Next week the Community Coordinator and Chairman to the Council will be helping the Chapelgreen Community Hub to put together and deliver the meals to the vulnerable and hampers to the families in need across the parish. Chairman Councillor John Housley also let the Committee know that this could not have been done without the support of the grant to Chapelgreen Community Hub from the Parish Council.</p>
