4. What is the purpose of your group – what difference do you make and how do you meet the needs of your community?

A field Hockey club, we have been in existence since 1951, celebrating our 70th anniversary in 2021.

We provide the opportunity for girls, boys, women and men (5yrs - 70yes+) to engage in playing the sport of hockey competitively and through training sessions. This benefits our members by developing their physical health, mental health and wellbeing and socially. We run 2 ladies teams, 3 mens teams and our junior section engage in youth hockey activities in the following age groups U10, 12, 14 and 16 years. The importance of physical activity as an aide to mental health and wellbeing has never been more important given the current restrictions. We offer junior coaching sessions and we help facilitate an In2Hockey tournament for the primary schools in the North of Sheffield in partnership with the Arches Sports Partnership.

5. What activity will you put on or project will you undertake if we give you a grant and when will this take place?

The project:

Following the initial rejuvenation of the synthetic grass surface in a Multi-Use Games Area (MUGA) at the Caribbean Sports Club in Ecclesfield in 2020, we are now looking to further improve the playing facility.

Ecclesfield PC kindly awarded us a grant payment of circa £9K.

The remainder of the rejuvenation costs – circa £4K were borne by Chapeltown HC with contributions from the Caribbean Sport Club.

The proposal primary purpose is to cover further rejuvenation costs - the least cost option. The improvements will protect the longevity of the playing surface and enhance what is already a fantastic venue.

This enhanced rejuvenation will allow improve the MUGA facility and extend it's lifespan. All our junior hockey coaching sessions are now based at the MUGA site and our junior section has now grown to almost 50 club members. Future development of the facility will allow the club to provide small-sided hockey games and small group activities for all ages (compliant with current and future COVID restrictions in line with government & England Hockey guidance). The target audience is primarily young people, current and future members. We aim to grow our youth membership by having this facility and presence in North Sheffield, targeting children attending the 7x primary schools in this area, and beyond.

The need for this project was brought about following the resurfacing of the artificial pitch at Ecclesfield School (March 2019), our previous base - which now has asurface that is unsuitable for hockey. This left us without a suitable playing facility in Sheffield - we had to travel to Barnsley (Darton College) to train and play

our senior competitive fixtures. Our junior base was at Ecclesfield school in excess of 20years and, we have played our senior matches at the school for the last 5 seasons, since losing the playing facility at Hinde House School, so you can appreciate the devastation this caused us when the decision to replace the surface with a 3G pitch was taken, leaving us without a pitch.

The initial Ecclesfield Parish grant contribution allowed us to fully renovate the playing surface and move all junior training to the MUGA facility at the Caribbean Sports Club which has the right type of surface for hockey (sand dressed synthetic carpet).

The facility is not only be used for Hockey, but the Caribbean Sports Club also are now able to provide additional football coaching sessions and cricket practice. This facility has become a thriving activity centre predominantly used by young people in the North of Sheffield.

Both clubs have ambitious plans to increase the usage, engage more young people over and above our current junior membership base of approx 50 to previous levels of 100+. The Caribbean sports club has strong connections with the Afro Caribbean community and again, we have discussed how we would like to extend the offer of hockey to their existing members and associates. We are an 'inclusive' club and have made a commitment to be 'mental health friendly'; welcoming members who may experience mental health problems and see our activities as a vital contribution to their ongoing support and wellbeing.

The MUGA is a much needed lifeline to the continuation of our club and retain our roots and presence in the North of Sheffield. Unfortunately the MUGA isn't able to accommodate our senior level competitive requirements due to it not being a full size pitch. We continue to work with England Hockey and Sheffield City Council to find a solution to this part of our dilemma.

Chapeltown HC and the Carribbean Club have committed to a comprehensive maintenance programme to keep the playing surface in good order. This bears a joint cost to the clubs of approximately £1500 per annum.
