Chapeltown Cycling Club (CCC), I established Chapeltown cycling club in May 2022 due to the lack of local groups in the parish area, the club started slow but has now begun to gain members from across the parish. This year we have registered with British Cycling, we would like to continue our membership with British Cycling next year and also apply for CTT membership to allow more exposure to possible new members and give young riders the ability to enter into events and races.
Joining British Cycling has allowed us to take the first steps into operating a Go ride scheme to encourage and help children access cycling and develop their talents and possibly into future champions. We have already been approached by the Chap Community Market who wish to provide a safe space for these Go ride events free of charge to help grow the local community.

We already have a wide variety of people using CCC from 19 year old men who are training to compete in their first race to 70 year olds who like to come out to keep fit on a Sunday plod. We have received a lot of interest from women about joining the club, we are currently recruiting a female riders representative.				
The main aim for our club is to remain a British Cycling affiliated club to be able to provide the Go-ride scheme to the local community for children aged 18 months to 18 years. These schemes offer an inclusive, fun and safe environment for all children with no prejudice to their gender or ethnicity. They will learn vital skills to ride their bikes in a fun way, allowing a natural progression to the cycling club and further if they wish to do so. All Go ride volunteers will be suitably qualified and DBS checked. We are planning to train all the volunteers in the remainder of 2023 and roll the program out in 2024.
