A voting/decision making event took place on the evening of the 7th October 2025 at Ecclesfield School at which 12 applications were considered. Council is asked:

(a) To note and ratify the following grant offers to the following groups:

- (i) £10,000 to 82nd Sheffield (Chapeltown) Scout Group to the removal existing toilets and rebuild new individual gender neutral cubicles
- (ii) £2,170 to 25th Sheffield (Ecclesfield) Scout Group for the purchase of new troupe tents and tent pegs
- (iii) £8,940 to Friends of Chapeltown Park for repairing of overlay flooring for the outside of gym area in the park
- (iv) £10,000 to Thorncliffe and Wentworth Cricket Club for purchase and installation of Astroturf and wicket installation
- (v) £3,890 to Always An Alternative to fund regular mobile youth club sessions and cover staff wages (partial award)
- (b) To confirm the following the grant offers via the Council's Small Grant Programme to the following groups:
